

2020 COVID-19 GUIDELINES AND RULES AT JUST CRUISING EQUESTRIAN

The following COVID-19 Guidelines must be adhered to when competing and/or attending Just Cruising Equestrian Center Horse Shows. In addition, all Federal, State, and local laws that may be applicable must be followed. Management reserves the right to change the guidelines when/if it is necessary. Failure to follow guidelines may result in expulsion from the show grounds. The best way to prevent illness is to avoid being exposed to the virus. (See <u>www.cdc.gov</u> or https://showmestrong.mo.gov)

If you plan to come to the Just Cruising Equestrian Center Horse Show, you must assure that neither you, nor anyone in your hoursehold has or is:

- 1. Tested positive or been presumed positive for COVID-19 at any time during the past 14 days
- 2. Been advised by a healthcare professional to self-quarantine at any time during the past 14 days
- 3. Been in close physical contact with someone who has tested positive for COVID-19 or who has been presumed positive for COVID-19, during the past 14 days
- 4. Subject to a quarantine order or on a recommendation of a healthcare professional that, in either case, would make it inadvisable to attend a public event or competition.
- 5. Within the past 24 hours, exhibited any of the following symptoms: fever of 99.9 or greater, cough, shortness of breath.

Social distancing guidelines must be followed at all times. Current guidelines call for a 6' minimum spacing between individuals. Do NOT gather in large groups.

- All personnel must check their temperature prior to arriving on the show grounds. Personnel with a temperature of 99.9 or greater should not attend the Horse Show.
- Wash your hands often with the hand sanitizer buckets provided at the horse show or frequently use a hand sanitizer that contains at least 60% alcohol. The use of gloves is encouraged, but not required.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Please wear a cloth face cover or mask when not riding or training. The use of masks will be in compliance with current Missouri Phased guidelines and with Boone County guidelines.
- The horse show office will be located outside. Please stay 6 feet apart when in line for the show office. Masks must be worn at all times when at the show office.
- Please do not crowd the ingate area. Specific presentation procedures for collection of awards will be announced prior to and during the show.
- Exhibitors should take photos (using smart phones) of the posted courses to avoid large gatherings.
- Please do not enter the barn without specific permission from horse show management. A Porta-Potty will be available and the show office will be located outside.
- Management will provide daily guidelines and reinforcement for attendees to address issues such as awards distribution, office and entry policies, and other important guidelines and announcements pertinent to the daily activities.

Thank you for your compliance and help in keeping the Just Cruising Equestrian Center Horse Show, our families and staff as safe as possible. We are very excited to return to showing and need everyone to work together to make this event safe and successful. Just Cruising Equestrian Center management and staff will do everything we can to ensure a positive experience for all involved. Working together, we can all do our part to keep ourselves and each other safe while still enjoying this sport and these animals we love!!
